Behavioral Health Homes is a collaborative approach to providing you with a comprehensive plan of care designed by your behavioral health and medical providers. This is a MaineCare funded service designed to help you manage your behavioral and physical health needs more effectively. The BHHO has a comprehensive behavioral health team that will support you in your journey to a healthier life. Inquire about our Free Care Program for uninsured clients who need help too!

"Counseling" or outpatient therapy is utilized by individuals who seek to make a change or adjust to a change in their life, but need some guidance or support in doing so. We use a collaborative process, involving a non-judgmental, supportive counselor who works with a client to tell their story, identify what they want to change, set viable goals and develop the strategies necessary to accomplish their goals. We work with our clients in making change in the way they think, feel, and behave. We work with our clients on developing healthy copings, healthy relationships and a healthier life for themselves. For some people this process takes a few visits, but for others, the process will take much longer. We will support you in reaching your goals independently; or, with your approval, we can involve family members or significant others.

We support the exploration of their interests and passions, and help them find new ones. These homes are staffed 24/7 in the ratio needed to support the level of care the resident requires.

**Notes:** Gateway Community Services provides Case management through the Section 17 program provides adults with support in increasing their independence in everyday life. Case managers support clients through linking them to needed services such as mental health support, medical care, housing services, transportation, education, and employment opportunities. Case managers seek to support clients who are struggling with mental health condition to become more independent in their communities and more able to navigate the systems with which they engage in their everyday lives, such as DHHS, Mainecare, FedCap, and the like.

Gateway's counseling program serves clients of all ages, and clinicians can see clients in their homes, the community, or in the traditional office setting. Clinicians are adept at addressing both mental health and behavior health concerns. Common issues that we work on in counseling include helping clients learn to cope with and move past traumatic experiences, managing anxiety, overcoming depression, learning anger management, and dealing with problematic interpersonal relationships. \*\*Note: Do NOT accept clients with Medicare insurance for counseling.\*\*

Personal Support Specialist (PSS), also known as Personal Care Assistant (PCA), is an individual who provides in-home Personal Care Services to both the elderly and disabled adult population throughout Maine. The PSS/PCA provides hands-on assistance with tasks of daily living. In order to qualify for PSS services, you must either contact your primary care provider or Maximus and request an assessment. Once you complete your assessment you will be assigned a Care Coordinator and will be placed on the statewide waitlist.

Maine Behavioral Healthcare, formerly known as Community Counseling Center, offers family, individual and group therapies to all populations and self-identifies as welcoming to LGBT (Lesbian - Gay - Bisexual - Transgender) community.

The Case Management program provides a full range of services to people with developmental disabilities, including advocacy, referrals, and connections to local resources. Geriatric Case Management is available for clients eligible for MaineCare and who have a mental illness diagnosis (Axis I or 2, GAF 50 or less) or consent decree member

Maine Behavioral Healthcare's Assertive Community Treatment (ACT) is an intensive community based (outpatient) treatment program with a multi-disciplinary team of providers that supports MaineCare eligible adults who may have a major mental illness diagnosis and often co-occurring disorders. The goal of the ACT Program is to improve the client's functioning in the least restrictive setting, while strengthening family, work, school and community ties

Elderworks is a day support program that provides group therapy services to older adults with chronic mental illness. Through this program, clients are able to engage with one another and individually with clinicians, while learning how to cope with depression, anxiety, isolation, and social stigma.

Clinicians and Case Managers fluent in American Sign Language provide mental health services to deaf and hard of hearing, deaf-blind, and late deafened adults and children in a deaf-culture friendly program. The team serves people throughout Maine, as well as family members of deaf individuals.

Service area is Cumberland County and Northern York County. Fees: Accepts most private insurance, MaineCare & Medicare.

**Notes:** MVRA (Maine Vocational Rehabilitation Association) provides community support to Adults receiving Section 20, 2 or Section 29 Support Waiver. This is a group program that focuses on community integration and learning independent living skills. Our Community Support program is an HCBS waiver program geared around member choices and informed decision making. We focus on life skills, informed decision making, and getting more involve with the community.

Clinical Case Management (Also known as Community Integration Services as defined by the State of Maine). We help consumers connect to services and actively engage with service providers in such areas as medication management, therapy, housing, Vocational Rehabilitation, and much more. We are able to assist with assessment, planning, evaluations, and help monitor your well-being. Services are individualized and in accordance with an Individualized Treatment Plan and are provided by certified and experienced staff.

Outpatient Therapy- Provides professional assessments, counseling, and therapeutic services. These services are provided to individuals seeking to improve functioning, address symptoms, relieve excess stress, and promote positive orientation and growth.

The goal of these services is to increase integrated and independent levels of functioning.

MVRA Mental Health Clinic Jail Program- The Jail Program works with individuals in the criminal justice system diagnosed with a severe and persistent mental illness. The Jail Program ensures delivery of clinically appropriate mental health services, addressing co-occurring issues, working collaboratively with Probation/Maine Pretrial Services, and supporting the individual's re-entry into the community identifying the necessary approach to reduce recidivism.

Community Support Programs offer a range of activities that are individually tailored, with attention paid to personal interests sensory issues, and other identified needs. There are sites in Limerick, Westbrook, North Yarmouth and Portland. Shared Living offered by Spurwink helps adults with a developmental disability or autism create a meaningful and connected life.

Spurwink also provides services to support foster families and children in foster care.

ShifaME's Multicultural Care Coordinators partner with youth and families, natural supports, and service providers the home, school, and community to reduce barriers that face refugee, asylee, and immigrant families. ShifaME counseling is a service for children and families who have experienced trauma or severe stress associated with being a refugee, asylee, or immigrant. This includes stress related to trauma, acculturation, resettlement, or isolation. The model for treatment is Trauma Systems Therapy adapted for Refugees (TST-R).

Spurwink Center for Safe & Healthy Families, formerly known as the Child Abuse Program, was developed in 1994 in response to the need for expert diagnostic services for children who may have been abused. The program serves children throughout Maine with clinics in South Portland, Bangor, Lewiston, and Augusta.

Provides Psychiatric medication management, Psychiatric nursing, Therapy in conjunction with medication management, and Assertive Community Treatment (ACT). ACT provides psychiatric treatment, vocational/employment supports and community support, case management. Eligibility: Adults with MaineCare who suffer from serious and persistent psychiatric disorders, mental retardation or Autism. Referral from a clinician/medical provider is required

The Behavioral Health Home (BHH) delivers integrated care to people who struggle with mental health. BHH care coordinators help clients consider their needs around housing, health care, finances, work, education, social and recreation time, and other areas that are important to them. Together clients and care coordinators use this information to develop a treatment plan made up of individual goals and preferences. Adult residents of Cumberland County (18 and over) who have been diagnosed with a mental illness and who are covered by categorical MaineCare.

Gordon Green: An eight-bed permanent residence providing intensive treatment and support for elderly adults under guardianship with a combination of challenges including mental illness and disabilities related to age or physical impairments.

Helen Winslow Ray House: A seven-bed comprehensive rehabilitation residence providing support, counseling and advocacy for adults with a major mental illness.

Morrison Place at Randall Street: This 12-bed facility, serving homeless men and women from across the state offers intensive individualized treatment, education around mental health diagnosis and the complexities of co-occurring disorders, coping skills to help manage symptoms, and relapse prevention skills such as anger management, conflict resolution, ADL skills, and transitional living skills.

Broadway Crossings: Adult Crisis Stabilization Unit, with a capacity of eight adult beds, is a short-term crisis stabilization unit providing a consumer-friendly alternative to hospitalization that allows people to remain connected to their support networks in the community. Broadway Crossings Adult Crisis Stabilization Unit can be accessed by calling The Maine Crisis Line (MCL) at 1-888-568-1112. Or (207) 799-4160

Ocean St: With a capacity of eight residents, provides trauma-informed treatment and support services to adults living with mental illness complicated by co-occurring chronic health conditions as well as a potential substance use disorder.

PATH program- Provides outreach to homeless individuals (sleeping outside, in a vehicle, or any place not meant human habitation) struggling with mental health or substance use, and currently unconnected to resources.
