**Notes:** The Clinics at Maine Law, established in 1970 as the Cumberland Legal Aid Clinic, is a program of the University of Maine School of Law, and is a small legal services provider in which clients are represented by "student attorneys". Maine Law students are specially licensed by the state and federal courts to provide legal services to low-income clients. The student attorneys practice under the supervision of fully-licensed attorney faculty members.

The Clinic represents low-income individuals with legal cases in Southern Maine courts (Cumberland, York, Sagadahoc, and Androscoggin counties) for most kinds of civil, criminal, juvenile, and family law matters. The Clinic represents clients at both the trial and appellate levels. The Clinic asks clients to pay a \$10 administrative fee. In some cases, clients may be asked to pay court and other significant costs. The Clinic does not otherwise charge for its services.

Individuals qualify for our services when:

Their household gross income falls within our financial guidelines;

The court is within our geographic service area; and

We have openings for new clients.

Because our resources are very limited, the Clinic cannot accept every case that meets our eligibility requirements. Therefore, we determine whether to accept a case based upon other factors, such as the availability of assistance from other legal services providers, the client's need for legal representation in the matter, the type of legal issue presented, and the potential learning experience for the students.

Disability Rights Maine (DRM) is Maine's Protection & Advocacy agency for people with disabilities. This means we represent people whose rights have been violated or who have been discriminated against based on their disability. We also provide training on rights and self-advocacy and we advocate for public policy reform. DRM believes that people with disabilities must: be treated with respect and be free from abuse; control the decisions that affect their lives; receive the services and supports necessary to live independently; have the opportunity to work and contribute to society; have equal access to the same opportunities afforded all other members of society; and full participate in all aspects of society: education, work, and community.

DRM provides the following services: Information and Referral; Individual Advocacy; Legal Representation; Education and Training; Assistance with Self-Advocacy; DRM welcomes calls from people with disabilities inquiring about their legal rights. However, DRM does not advise landlords, schools, businesses, or providers of accommodations or services.

Deaf Services and Communication Access issues should now be addressed to Disability Rights Maine, who will be administering the Telecommunications Equipment Program, the Civil Rights Program, and the FCC's Deaf Blind Program as well as others. They also offer the Telecommunications Equipment Program (TEP): Provides communication solutions to anyone who has a barrier that prevents them from using standard phone equipment. Hearing Aid access for low-income clients, ages 65 and older, may qualify to choose either an adaptive telephone OR a single telecoil-equipped hearing aid. Individuals who complete the TEP application and appear to qualify for the hearing aid option will receive a letter notifying them of their eligibility. Eligibility Levels- Lending: For people with limited income, no cost to clients, equipment can be borrowed for as long as it is needed. Cost-Share: For people with moderate income, cost is based on a sliding-scale, client pay a one-time fee. **Notes:** LSME provides persons age 60 and over with free legal advice regarding health care, health insurance, Medicare (including Part D), MaineCare (Medicaid), Social Security and other public benefits, pension and retirement benefits, powers of attorney, consumer matters including creditor and bankruptcy problems, physical and financial abuse, guardianship defense and other issues. LSME does not handle criminal matters, divorces, or personal injury cases. Even if LSME can't help you, we may be able to refer you to another legal resource, like Volunteer Lawyers Project or a private attorney at a reduced rate.

The Helpline provides legal information, advice and brief services on many legal problems and questions that often come up for older people. We advise older people about consumer problems, like debt collection and home repair contracts, MaineCare, Medicare, long term care, housing, public benefits, advance health care directives, financial powers of attorney, and other civil (non-criminal) matters. The Helpline is open Monday-Friday 9 a.m.- Noon and p.m. - 4 p.m.

When you call, you will talk to our intake paralegal. Our paralegal will ask you for some basic information about yourself and your legal problem. One of our Helpline attorneys will call you back. If it is not an emergency, you will typically get a call back within three to five working days. It's very helpful to be ready with any important papers and other information when the lawyer calls. If you are calling for an older person who needs legal help, we may need their permission before we can talk with you about the legal problem.

**Notes:** The Maine Human Rights Act ("MHRA") is Maine's anti-discrimination law. It prohibits discrimination on the basis of protected class in employment, housing, places of public accommodation, education, and extension of credit. Protected classes include: race, color, ancestry, national origin, sex, sexual orientation (which includes gender identity and expression), physical or mental disability, religion, age, and other categories in certain contexts. The MHRA also prohibits retaliation for asserting MHRA-protected rights.

The Maine Human Rights Commission is the state agency charged with enforcing Maine's anti-discrimination laws. The agency investigates complaints of unlawful discrimination in employment, housing, education, access to public accommodations, and extension of credit.

Any person who believes that he or she has been subjected to unlawful discrimination may file a charge. Completing the Intake Questionnaire does not necessarily mean that a complaint of discrimination has been filed. After we receive the information you provide, the Intake Officer will either type a complaint of discrimination and send it to you for your review and notarized signature or, if the information is not sufficient to draft a complaint, call you to discuss your allegations further. A perfected complaint of discrimination is filed with the Maine Human Rights Commission when a signed, notarized complaint form is received by the commission. Complaints must be received by the commission within three hundred (300) days of the alleged act of discrimination.

Not all discrimination is unlawful! Please call to request an intake questionnaire; An Intake Officer will assist you with drafting a charge.
